RULES and regulations

Open call for graphic art competition and exhibition Miniprint Finland 2010 organized by Graphic Artist Association of Lahti and Lahti Art Museum, Finland

- 1.** The competition is open to all artists and all traditional print art techniques, including digital and unique print methods are accepted. Every participating artist can offer **maximum of 3** pieces of graphic works produced in the years 2007 - 2010. The motif of the works is not limited.
- 2.** The maximum dimensions of the artwork is **17 x 20 cm**. The maximum size of the printing paper is **30 x 35 cm**. If the works are printed on 3 dimensional material, the depth of it cannot exceed 5 cm. If the size of the offered art works exceeds these restrictions, they will not be considered for entry into the exhibition.
- 3.** The number and the title of the work has to be marked clearly, on the back side of the artworks, corresponding the notes on the participation and information form.
- 4.** Please send the signed artworks, participation- and information form, CV (curriculum vitae) and a copy of the receipt of the participation fee as "PRINTED MATTER/ NO COMMERCIAL VALUE" in a simple package to the address: **Lahti Art Museum, P.B. 113, 15111 LAHTI, FINLAND by May 15th 2010**. Mark on the package "Miniprint Finland 2010".
- 5.** Participation fee is **EUR 40** which covers handling of the artworks, jurying and return postage. Please, send the money transfer to the following bank account; Graphic Artists' Association of Lahti (Lahden Taidegraafikot ry):

6. The organizers will publish a catalogue of the exhibition including one photo of artwork from each participant. The price of the catalogue is **EUR 40** . It can be ordered by the participation-form and after the exhibition by e-mail.

7. The selection of the exhibition-, and the winning graphic works will be executed by an international 6-membered jury. Names of selected artists will be published on the internet sites www.lahdentaidegraafikot.fi after the jury's decision (July 15 th 2010). Rewarded artworks: Grand Prix (EUR 2000), three special prizes (á EUR 1000)and 1-3 honourable prizes will be announced on the opening day of the exhibition. **The awarded graphic prints will become property of Graphic Artists Association of Lahti, and might be donated for the sponsors of the event.**

8. All participating artists will be informed the jury´s decision by 31.8.2010. Excluded works will be returned by 31.9.2010. The jury's decision cannot be reclaimed.

9. The organizers will take 30 % commission fee in case of selling the prints. If the artist has more prints to sell, it can be informed on the participation form.

10. Although all the prints will be handled with maximum care, the voluntary insurance can be taken by the artist. The organizers will not pay any compensation for artists or their representatives.

11. The exhibited prints will be returned within three months from the closing date of the exhibition.

12. By signing the participation form, the artist will accept these rules of the competition.
